Current Worldwide Affairs on Climate Change

Climate change is one of the major challenges of our time and the United Nations is working on finding ways to battle it.

The United Nations Framework Convention of Climate Change (UNFCCC) was issued in 1992 and now has almost universal membership because 197 countries and regions are members.

In 1995 the Kyoto Protocol was introduced that legally binds developed country Parties (192 up to the day of issuing this magazine) to emission reduction targets.

There is also the Paris Agreement that builds upon the belief that all countries should undertake ambitious efforts to combat climate change and adapt to its effects with enhanced support to assist developing countries to do so.
